OVERVIEW

The annual Import Goods Fair (IGF hereafter) is a flagship project organized by Korea Importers Association (KOIMA hereafter) since 2004. Between June 23 25, 2022, KOIMA has successfully hosted The Import Goods Fair 2022 (IGF 2022 henceforth). IGF 2022 marks the 19th anniversary of this annual event. 91 exhibitors, including 57 embassies, from countries, comprised of Korean importers, foreign exporters, the foreign Embassies in Korea, and other partner organizations participated, occupying in 121 booths.

As a trade organization that focuses on import, KOIMA has proudly organized 7 Seminars on trade policy and business strategy, along with 184 B2B Meetings, both online and offline. B2B has been the buzzword throughout KOIMA's preparation of the IGF 2022. From the onset, KOIMA spared no effort in making sure this event rightfully serves the interest of businesses across the world. The Import Goods Fair 2023 is scheduled to take place from June 29th 2023 to July 1st 2023 at COEX, Hall C1 & C2, Seoul, Korea.

GOALS

The annual Import Goods Fair aims to achieve mainly three things.

1 Intermediating B2B Meetings

B2B Meeting is at the heart of KOIMA's mission. For businesses unfamiliar with the Korean market, matching up with the right business partner is at the crux of making their way to the Korean market successfully. Korean businesses are as interested and eager to importing competitive commodities from outside of Korea. They always eye on new products that are like to fare well in the country. B2B Meeting may not be an end of itself, but an important steppingstone to achieving mutual benefit.

② Consolidating Global Network

B2B Meeting is likely be in void until and unless supported by the Embassies and Trade Representatives in Korea. For the IGF 2022, we were delighted to have 61 countries represented at the Fair, not to mention 57 Ambassadors at the opening ceremony of the event. The **IGF** Secretariat 18 looking forward to increasing that numbers. Going forward, any embassies or trade missions in Korea unrepresented in our previous events are more than welcomed to take part in KOIMA's future events, the IGF in particular.

3 Attracting Prospective Consumers

It is almost indisputable that consumers, in the end, are the real VIPs to our event. Neither intermediating B2B meetings nor consolidating KOIMA's global network is more important than attracting visitors who are highly likely to become the consumers of showcased commodities.

The IGF Secretariat understand and acknowledges that visitor attraction was an area that it unfortunately fell short of at the IGF 2022. We highlight that this was in big part due to the lingering aftermath of the COVID-19. While the IGF 2022 was designed to mark a fresh and vigorous rebound back to business, garnering the interest of ordinary consumers still had a long way to go.

However, we also reiterate that this will be an area that the Secretariat plans to make an improvement on in times to come. This will include allocating more budget on social media marketing, advertising the event more proactively using the Association's social media accounts (Facebook, Instagram, YouTube, etc.), increasing media presence, and numerous other efforts, as necessary. This, however, cannot be done by KOIMA alone. Only through coordinated efforts with the Embassies in Korea and other partner organizations can KOIMA make a substantial difference.






Closing

Korea Import Fair 2023

1. TERMS OF REFERENCE

- 1) The term "exhibition" shall mean "KOREA IMPORT FAIR 2023"
- 2) The term "organizer" shall mean "Korea Importers Association (KOIMA)", Seoul, Korea.
- 3) The term "exhibitor" shall mean the individual, company, or organization who has applied for the exhibition.

2. APPLICATION FOR PARTICIPATION

- All applications for participation shall be made on the prescribed application form, which shall be submitted to the organizer.
- 2) The "exhibitor" must submit the application form duly signed along with 50% of the participation fee including any additional utility service charge. The organizer, however, may defer or refuse the acceptance of an application if sufficient space is not available, or the announced exhibit is considered by the organizer not germane to the exhibition, and though the application form has already been submitted, the organizer will return the application form and the participation deposit money one month before the exhibition.
- 3) The "exhibitor" should inform the "organizer" about any changes made on the submitted documents including the application form and all the other forms, immediately. Any losses incurred by failure to report shall be covered by the exhibitor.

3. TERMS OF PAYMENT

- 1) 50% of the deposit of the participation fee and/or relevant stand charges must be paid at the time of the application by the exhibitor and the balance shall be paid not later than May 31st, 2023. (The exhibitor may pay the full participation fee at the time of application.)
- 2) The participation fee shall be paid by the due date. Otherwise, the organizer has the right to cancel the contract and to dispose the space at their discretion. And in case they do the participation fee already paid shall not be refunded.
- 3) If the application fee and utility fee are not paid in full, the organizer shall reserve the right to seize the exhibit.

4. ALLOCATION OF EXHIBIT SPACE

- 1) The organizer shall allocate the space in accordance with the order of application, size of the space applied for, and the nature of the exhibits. The exhibitor cannot make a formal objection to the allocation.
- 2) The organizer shall reserve the right to change the location and/or the size of the space allocated to the exhibitor at any time prior to the commencement of the build-up of the exhibition, should exception circumstances demand, and the exhibitor shall have no claim for compensation as a result of any changes.
- 3) Under no circumstances may the exhibitor resell, transfer rights to, or enter into a mutual agreement to change assigned booth(s) with another party, without the prior approval of the organizer.

5. USE OF THE EXHIBIT SPACE

 The exhibitor shall exhibit their stated products and must have competent personnel in their booth(s) during the entire period of the exhibition.

- 2) All exhibits must accord with the statement on the application form and be related to the theme of the exhibition. Public auctions and sales without permission of the organizer are strictly prohibited. If the exhibitor violates the above-mentioned rules, the organizer can stop the exhibitor's activity, remove his/her exhibits, or order the dismantling of his/her booth. In this case, the participation fee shall not be refunded, and the exhibitor shall have no claim for compensation.
- 3) The organizer shall have the right to prohibit certain persons from entering the exhibit.
- 4) The exhibitor shall operate and demonstrate its exhibit so as not to annoy, endanger or interfere with the rights of other exhibitors or visitors. Any practice resulting in complaints may be prohibited by the organizer.

6. BREACH OF CONTRACT AND WITHDRAWAL BY EXHIBITOR

- 1) In the event of abandonment or rejection of all the allocated space or the partial space, the exhibitor shall notify the organizer in writing immediately. In this case the participation fee already paid will not be refunded.
- 2) If the notification is made before May 31st, 2023, the participation fee except the deposit shall be refunded.
- 3) The refund fee shall not bear any interest.

7. CANCELLATION AND CHANGES OF THE EXHIBITION

In the event of the cancellation of the exhibition by the organizer, the participation fee paid will be refunded fully. But if the cancellation was caused by force majeure such as an act of nature or war, the fee will not be refunded. In this case, the exhibitor shall have no claim for compensation from the organizer.

8. CONSTRUCTION AND DECORATION OF STAND, DISMANTLING, AND RESTORATION

- 1) All exhibitors must complete their construction and/or decoration and move in and display their exhibits by the date and time stipulated by the organizer.
- 2) Modifications including decorations such as painting the floor, ceiling and pillars will not be permitted. The exhibitor shall be responsible for compensating any damages to the facilities of the exhibition hall.
- 3) Exhibitors shall remove all exhibits and stand fittings from the exhibition hall within the period stipulated by the organizer and indemnify the organizer against any cost incurred by reason of delay or damages to the facilities of the exhibition hall.

9. SECURITY, RISK, THEFT, AND INSURANCE

- 1) The organizer shall protect the exhibits and visitors from potential safety hazards.
- 2) The exhibitors shall be held responsible for any loss or theft of, or damage to exhibits, stand fittings or any articles belonging to the exhibitors during the construction, exhibition, and dismantling periods.
- 4) If the exhibitor intentionally or negligently causes a fire, theft, breakage, or other accidents inflicting damages to the organizer or others, the exhibitor shall be responsible for those damages. And the exhibitor shall also be responsible for insuring the exhibits.

10. FIRE REGULATIONS

- 1) Materials used in stand and display construction must be properly fireproofed in accordance with the pertinent regulations of Korea.
- 2) The organizer has the right, should circumstances necessitate, to make changes in the exhibitor's stand for fire control.

11. SUPPLEMENTARY CLAUSES

- 1) Whenever necessary, the organizer shall have the right to issue supplementary regulations in addition to the terms and conditions.
- 2) Any additional written regulations or instructions shall form part of the rules and regulations for participation in the KOREA IMPORT FAIR 2023 and they shall be binding on the exhibitors.
- 3) The exhibitor shall also observe the regulations stipulated by the management of the exhibition halls of COEX.

12. ARBITRATION OF DISPUTES

Any dispute, difference, or question which may arise at any time hereafter between the organizer and the exhibitor of these terms and conditions for participation or the rights and liabilities of the parties hereto shall be finally settled by arbitration in Seoul in accordance with the Commercial Arbitration Rules of the Korean Commercial Arbitration
