

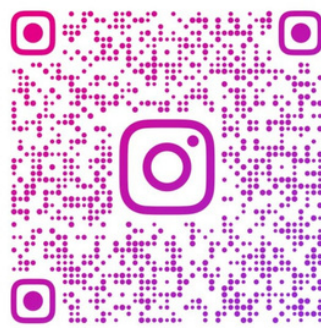

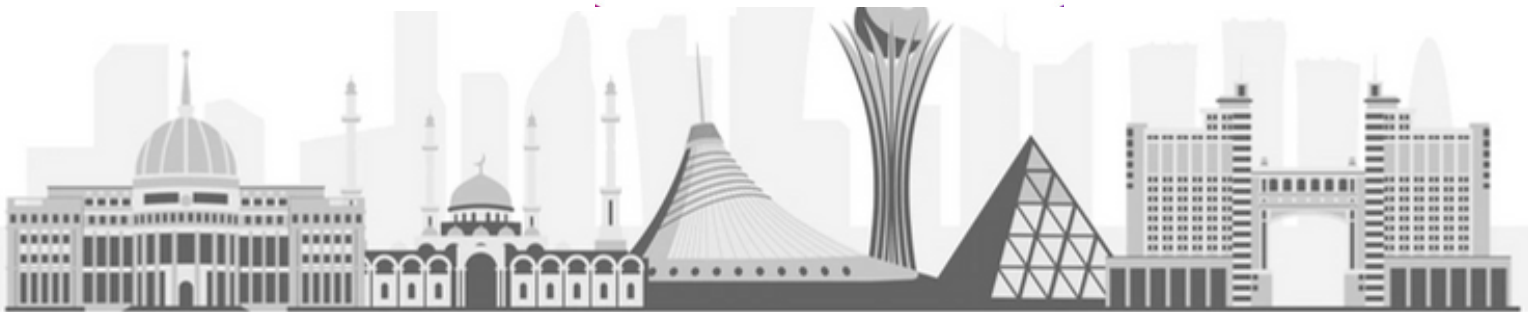

KAZAKHSTAN INVESTMENT BUREAU

The Kazakh business delegation will focus on meetings with government and business representatives to discuss investment and trade opportunities in Kazakhstan. The delegation will meet with officials of the Kazakhstan Investment Agency, the National Association of Entrepreneurs of Kazakhstan and the Ministry of Trade and Integration to discuss Kazakhstan's investment potential in a number of areas. In addition, the delegation will take part in the large Kazakhstan Round table on Global Investments (KGIR-2024), which will include thematic discussions between government ministers and major international investors. The delegation will also visit the Astana International Financial Center (AIFC) and meet with representatives of the Ministry of Digital Development, Innovation and Aerospace Industry. In Almaty, the delegation will hold B2B meetings with local companies to discuss investment opportunities and cooperation in infrastructure, technology and business. A visit to the Almaty region and Zhetysay is also planned, including familiarization with the International Center for Cross-Border Cooperation "Khorghos", a Dry port and large logistics hubs on the border with China.

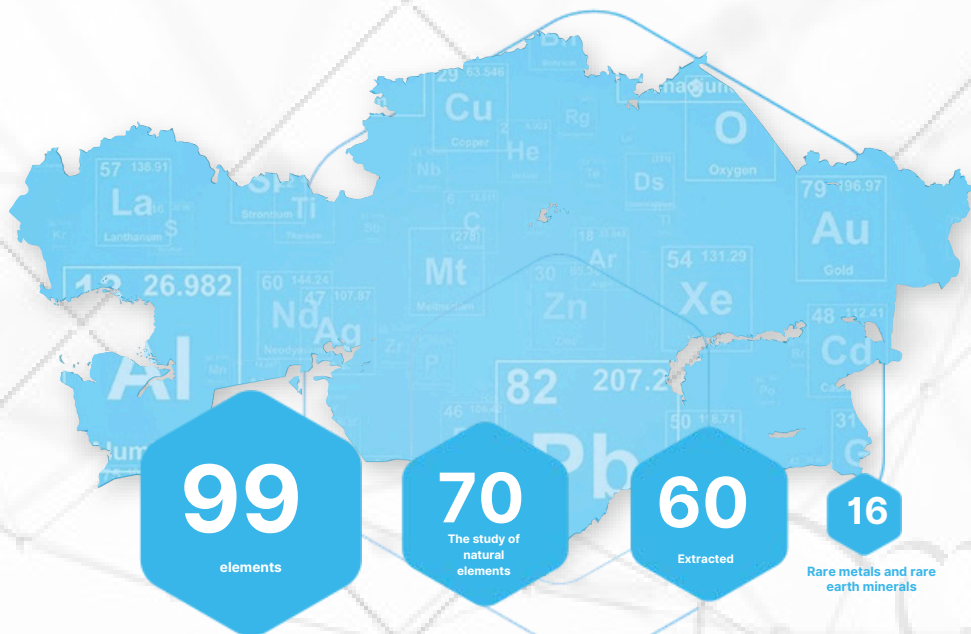

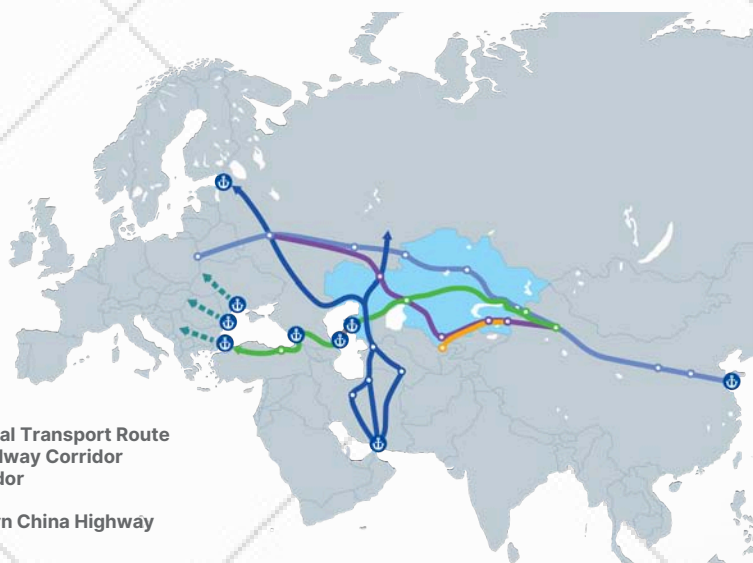

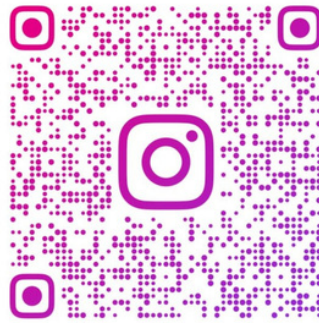
